NORTH CAROLINA BOARD OF OCCUPATIONAL THERAPY JANUARY 11, 2021 MINUTES

REGULAR SESSION

Time and Place

The North Carolina Board of Occupational Therapy met in Regular Session via Webex conference call on January 11, 2021 at 9:00 a.m.

Ms. Echols, Chair, called the meeting to order at 9:00 a.m.

Kevin Coates, MD and Young Kim

Ms. Echols administered the Oath of Office and Dr. Kevin Coates and Young Kim were sworn in as new members of the Board.

Conflict of Interest

Ms. Echols called for any conflicts of interest with the meeting agenda. There were no conflicts or potential conflicts.

Approval of Minutes

The November 16, 2020 minutes were approved.

Approval of Treasurer's Report

The treasurer's report for November 1, 2020 through December 31, 2020 was discussed and approved as submitted.

Administrator's Report

The administrator's report was reviewed and approved as submitted.

Legal Services Committee

Ms. Blackwell reported the Committee reviewed a bill from Broughton Wilkins Sugg & Thompson, PLLC for the months of November and December 2020 for twelve (12) disciplinary proceedings. AOTA

a. Email regarding definition of OT Practice

Board members reviewed an email from Kristen Neville dated December 18, 2020 regarding the definition of occupational therapy practice for the AOTA Model Practice Act. Ms. Kirk forwarded the email to the Board to provide feedback.

b. Guidelines for Reentry Into the Field of OT

Board members reviewed the new document from AOTA regarding guidelines for reentry into the field of occupational therapy and agreed there was nothing that needed to be added or amended to the Board's Practice Act or Rules regarding this topic.

Board members were advised the 2021 Annual Conference is meeting in San Diego, California on April 8-11, 2021. The Board agreed to present at the conference, if their presentation is accepted.

Email from Dan Logsdon regarding discussing the OT Compact with the Board

Board members reviewed an email dated November 18, 2020 from Ms. Kirk to Dan Logsdon with the Council of State Governments regarding the OT Compact. The subcommittee plans to meet prior to the March 2021 Board meeting and will contact Mr. Logsdon with any questions regarding the OT compact.

Response to Meredith Gronski regarding providing email addresses for the call for nominations

Board members reviewed an email dated January 8, 2021 from Mr. Wilkins to Meredith Gronski regarding providing email addresses for the call for nominations. The Board agreed to draft an agreement between the Board and

NCOTA to allow the use of email addresses solely for Board member nomination purposes. Mr. Wilkins agreed to draft an agreement for review by the Board and NCOTA.

NEW BUSINESS

Email from Mike Kachman regarding topical anesthetics

Board members reviewed an email dated January 5, 2021 from Mike Kachman regarding use by OT practitioners of topical anesthetics (Voltaren and Lidocaine, e.g.) for treating neuropathic pain and whether OT practitioners can recommend topical anesthetics for use by patients with neuropathic pain. The Board agreed it is up to the OT practitioner whether to use topical anesthetics in their practice. However, OT practitioners should not recommend (or prescribe) topical anesthetics for use by patients to manage their neuropathic pain. Neither the prescribing of medications nor the recommendation of use of medications, prescription or over the counter, is within the scope of practice of OT in North Carolina.

Jane Rourk's obituary

Mr. Wilkins informed the Board that Jane Rourk, OT/L #0001, passed away January 3, 2021. Ms. Rourk was a tireless leader of the OT profession as President of the NC Occupational Therapy Association and as the first Chair of the NC Board of Occupational Therapy. She was instrumental in establishing licensure for occupational therapy practitioners in NC. Board members spoke on behalf of Ms. Rourk's contribution to the occupational therapy profession. Mr. Wilkins agreed to send a card to her family to express their condolences.
